I \_\_\_\_\_, a Legacy Scholar participating in the Legacy Roundtable ACCELERATED SUMMER MATHEMATICS ACADEMY sign this contract as a commitment to do the following:

1. I will seek excellence in all my endeavors, be a model of high achievement, and bring honor to my family, the Legacy Roundtable and Community College. I will not wear baggy or sagging pants or other provocative attire during LEGACY ROUNDTABLE sessions. *My dress will be appropriate for a young business owner during the summer program.*

2. I will submit a *complete packet* of Legacy Roundtable registration materials before I can attend Pre-Assessment Tutorial sessions.

3. I must plan to attend LEGACY ROUNDTABLE ACCELERATED SUMMER MATHEMATICS ACADEMY PRE-ASSESSMENT TUTORIAL sessions. I must complete a minimum of 18 hours of Pre Assessment Tutorial services in order to be eligible to take community college mathematics assessments required for ASMA 2012.

4. I understand that the Legacy Roundtable will make final selections for the 2012 Accelerated Summer Mathematics Academy (ASMA) based on performances during the Pre-Assessment Tutorial sessions.

5. I understand that I will need to attend a minimum of twenty two of twenty four class sessions this summer or I will be dismissed from the program. In the event that I am unable to attend an activity or class, I will inform the Legacy Roundtable Program Coordinator and teacher in writing or by phone call; I understand clearly that: *students may be dismissed from program for: 2 unexcused absences or 3 unexcused tardies during the 6 week ASMA program.*

6. I understand that Legacy Roundtable staff serves as intermediaries with community college staff, administrators, and instructors; any comments I have about treatment from these representatives will be channeled first to the Legacy Roundtable Program Coordinator. If I fail to do so I or my child may be immediately dismissed from the program.

7. I understand that if I am not a US citizen or Permanent Resident in this nation or state, that I will be held responsible for paying all Non-resident fees associated with ASMA classes at any of the community college sites.

8. I will enroll in a college-preparatory curriculum throughout my years in middle or high school (following the University of California (UC) A-G course requirements) and strive to maintain at least a 3.0 grade point average (GPA) each semester. Although I am able to remain active in the LEGACY ROUNDTABLE program if I do not maintain a 3.0 GPA, I am expected to set a personal goal of maintaining a GPA higher than 3.0

9. I will submit copies of my Fall and Spring Semester report cards (if a student is attending a school on a quarter system, the student should submit final quarter grades) by March 1st of every year for Fall Semester grades and August 1st of every year for Spring Semester grades.

I will be responsible for informing the LEGACY ROUNDTABLE office of any change in my personal information including address, phone number, school, etc. I understand that if the LEGACY ROUNDTABLE office is not able to contact me due to incorrect information, I will automatically be dismissed from the program.

11. I will arrive to all LEGACY ROUNDTABLE sessions at the time designated. I know that if I do not arrive at the designated time, that I may be prohibited from participating in the activity (because I may be disrupting the session due to my late arrival) and will not receive attendance credit.

- \_\_\_\_\_ 12. I will put forth my best effort when completing **ALL** assignments. I will complete **ALL** assignments even if I am absent. When assignments are incomplete, my parent(s) or guardians will be notified.
- \_\_\_\_\_ 13. I will respect all LEGACY ROUNDTABLE staff, and scholars. Disrespectful acts include the use of abusive language, threats, malicious notes, theft, and failure to follow instructions from those in authority. The severity of the act will determine if I am dismissed from the program.
- \_\_\_\_\_ 14. I understand that pagers and cell phones are unacceptable at any LEGACY ROUNDTABLE session and may only be used during breaks in activities or classes.
- \_\_\_\_\_ 15. **MY PARENTS AND I CLEARLY UNDERSTAND:** *If I withdraw from ASMA 2011 community college courses after enrolled and books purchased using Legacy resources; I will be responsible for reimbursing Legacy Roundtable/Council of African American Parents, up to \$800 for resources spent during the Pre-Assessment tutorial component of this program.*
